## Terms & Conditions for Security Services

Sealed Technical (Strategy and Documents) and Financial bid in separate covers for Extension of 11 KVA line and Installation 1x315 DTR Transformer at Government Polytechnic, Bhagalpur are invited. The envelope should be superscripted "Extension of 11 KV line and Installation 1x315 distribution Transformer for giving new service connection of load 200 KVA at Government Polytechnic, Bhagalpur" with name and address of the Firm with phone and fax number.

1. On the opening date Technical bid will be opened. Financial bids of only Technically successfully bidders will be opened in presence of the Bidders/their authorised representative.
2. The Technical Bid shall also include the Presentation to be made by each Firm.
3. After evaluation of Bid, the successful bidder will be informed separately.
4. In case of any Govt. holiday or undeclared holiday or strike on the opening date, the tender will be opened on the next working day at the same time and for this no information will be published separately.
5. The agencies must put their initial on each page submitted. All pages must be numbered and a note of this should be mentioned on covering letter. The terms & Conditions duly signed should be attached with tender paper.
6. The tender fee of Rs. 1000/- (One Thousand ) only and E.M.D. of Rs. 49,778/- (Fourty nine Thousand seven hundred seventy eight) only in the shape of demand draft separately on any nationalized bank in favour of "Principal. Government Polytechnic.Bhagalpur" payable at "Bhagalpur." should accompany tender paper. Tender without tender fee and EMD will be ignored straightway.
7. The EMD without interest will be refunded to the unsuccessful Bidders after finalization of tender. However, the EMD of successful bidders shall be converted into security deposit and held by the Institute as performance guarantee for the entire period of contract but no interest shall be payable on the Earnest Money and the same shall after the end of the tender work be refunded after one year of work completion.
8. The agency must provide Three (3) years warranty to distribution transformer.
9. They have to start work within 03 days of intimation and complete within 45 days.
10. ROW problem must be resolved by the firm. Institute will not cover the any type of compensation for tackle of ROW problem.
11. The full EMD shall be forfeited in case of backing out of the offer before acceptance.
12. Incomplete tenders and / or tenders received after due date and time will not be considered.
13. Any effort by a bidder to influence the Institute in the bid evaluation, bid comparison or contract award decision directly or indirectly will attract straightway rejection of their bid without assigning any reason.



14. The Agency may be disqualified. It they have :
  - a. Made misleading or false representation of facts or deliberately suppressed due to information to be provided in the forms, statements and enclosures of this document.
  - b. Records of poor performance such as abandoning work, not properly completing the contract or financial failure/weaknesses.
  - c. The confidential enquiry reveals fact contrary to the information provided by the applicant.
15. Individual signing the bid or other documents connected with the contract shall indicate the full name below the signature and must specify that whether he is signing in the capacity of; i) a sole proprietor, or ii) a partner of the firm in which case, he must have the authority to represent the firm for arbitration of disputes concerning the business of the partnership firm either by virtue of the partnership deed or power of attorney, iii) constituted attorney of the firm.

19. The bidders should submit an affidavit by a Notary Public that they are not having any case pending against them anywhere nor have they been found guilty in any criminal case.
20. The agency must be in possession of Labour License for running security services. (Enclose copy).
21. The agency should have ISO certification, OHSAS Certification quality and environmental management certificate or any other qualification (enclose copy).
22. The agency must have minimum average annual turnover during the last 3 years, ending 31<sup>st</sup> march of the previous financial year, should be at least 30 % of the estimated cost. (i.e Rs. 7,46,674.00) (enclose audited statement of account by C.A. Or TDS Certificate of last 3 years, (Pertaining to security service)
